### Students' Needs:

Academic Needs	<p>Added a designated intervention time to class schedules to ensure students in Tier II and Tier III are getting regular, ongoing in-class interventions, implementing MTSS across all grade levels and conducting quarterly meetings with all homeroom teachers to review data of students in need of Tier II/Tier III interventions, increased accountability and follow-up with teachers supporting students with a Tier III SST Intervention Plan by meeting every 2-3 weeks with the SST Coordinator. Literacy specialists and EL teachers will learn, implement, and train homeroom teachers, in Heggerty Phonemic Awareness (over 2 years, 2021-22, 2022-23); Assistant Headmaster will provide progress monitoring packets to help teachers implement/hold teachers accountable to consistent progress monitoring for students that require Tier II support. Identified students scoring partially/minimally proficient on AzM2 and requiring Tier II/Tier III interventions in ELA and/or Math.</p>
Social, Emotional, and Mental Health Needs	<p>Quarterly meetings between homeroom teachers and SST Coordinators to discuss student needs; 45-day screeners. Check-in's between HR teachers and SST coordinators for students in SST will occur every 1-3 weeks; more frequent meetings available upon</p>

During these meetings, the HR teacher and SST Coordinator will partner together to review data/observations, develop interventions, and develop a plan to track progress; Provide teachers with on-going Professional Development sessions on identification of social/emotional needs, as well as providing strategies to support meeting students social/emotional needs within the general education classroom; Small support groups or social groups; Referrals to receive 1:1 or small group support from Archway Scottsdale's School Counselor; Teachers can navigate to the Archway Scottsdale SharePoint to sign-up for a time to consult with ACS's school counselor during office hours.
Other Needs (which may include student health and food services)	School will follow CDC's "No Share" Food Policy; All Faculty trained in identifying symptoms of illness specific to COVID-19 and instructed to take immediate action when students appear to be exhibiting symptoms.
<b>Staff Needs:</b>	
Social, Emotional, and Mental Health Needs	Gathering feedback from various members of the Archway Scottsdale Leadership team regarding staff morale. Post mental health resources and network approved provider list on Archway Scottsdale Share-point for all faculty to access; Teachers can navigate to the Archway Scottsdale Share-point to sign up for a time to consult with Archway Scottsdale's School Counselor during office hours; Provide staff with ongoing Professional Development sessions focused on the thematic goal of Trust Collaboration, being an ideal team player, and building and maintaining healthy teams; The Archway Scottsdale Sunshine Committee exists to create opportunities for faculty to connect with one another and engage in creative, fun, non-work related activities; Provide teachers with on-going Professional Development sessions focused on Teach Like a Champion 2.0 strategies; Weekly or bi-weekly lesson observations and coaching sessions with an instructional coach; Check-in's between HR teacher and SST coordinators for students in SST will occur every 1-3 weeks; more frequent meetings available upon request. During these meetings HR teachers and SST Coordinator will partner together to review data/observations, develop interventions and track progress.
